Please note that federal judges should not draft letters of recommendation on an applicant's behalf (*Committee on Codes of Conduct, Adv. Op. No. 59*).
- Submission of an application indicates the applicant's willingness to serve if selected.
- The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, *Pub. L. No. 95-521, 92 Stat. 1824 (1978)* (*codified as amended at 5 U.S.C. app. §§ 101-111*).
